#### 3. Federal Transit Administration Section 5311 Program of Projects

The Transportation Committee was asked to recommend the Board of Directors approve the Federal Fiscal Year 2024 apportionments of Federal Transit Administration Section 5311 Non-Urbanized Area Formula Program funds for the San Diego region.
