SUBJECT: SANDAG LEGISLATIVE REPORT – AUGUST 2024

Legislative Overview

The Legislature returned from Summer Recess on August 5th and, following a final chaotic month, will conclude the 2023-24 Legislative Session on August 31st. The remaining schedule for this year includes the following key dates:

- September 30: Last day for Governor to sign or veto bills
- December 2: 2025-26 Regular Session convenes for Organizational Session

LOSSAN Bill SB 1098 (Blakespear) Passed by the Legislature

SB 1098 was introduced by Senator Catherine Blakespear on February 13th to assist the LOSSAN Rail Corridor by, according to the author, "align[ing] state and local action by requiring action plans and recommendations that result in improved services for passengers."

Throughout the course of the legislative year, SB 1098 received several amendments, and the final version will require the Secretary of the California State Transportation Agency (CalSTA) to convene a working group regarding the LOSSAN Rail Corridor. Amongst other stakeholders, the bill would include SANDAG and other impacted Metropolitan Planning Organizations, to develop recommendations to ensure the long-term viability of comprehensive and coordinated passenger and freight rail services in, or that connect to, the LOSSAN Rail Corridor. Under the bill, these recommendations would be included within a report submitted by CalSTA to the Legislature by January 1, 2026, regarding the performance of the rail corridor, as well as any recommended actions to improve service, ensure resiliency, connect with other passenger rail services, and achieve environmental goals.

The bill received widespread support, including support from SANDAG, and was ultimately passed by the Assembly on August 26th, and passed by the Senate on concurrence on August 28th. SB 1098 will now be sent to the Governor for his signature.

SANDAG-Supported AB 2485 (Carrillo) Held by the Senate Appropriations Committee

Assembly Member Juan Carrillo introduced AB 2485, sponsored by the Southern California Association of Governments (SCAG), to require the Department of Housing and Community Development (HCD) to convene an advisory panel and publish the data and methodology it uses to calculate each region's housing needs in the Regional Housing Needs Determination (RHND) process.

As background, the California State Auditor's report published in March 2022 on HCD's RHNA determination process highlighted the need for accountability and transparency on HCD's methodology and assumptions. AB 2485 addressed these concerns and would have improved the development of this process by both establishing procedures for HCD to publicize its data sources, analyses, and methodology on its website and requiring HCD to establish and convene a panel of experts to provide advice to the Department on its assumptions, data, and analyses before making its final determination on a region. These improvements would have aided councils of governments, like SANDAG, and other interested parties in ensuring accuracy within the RHND process, thus increasing confidence in the state's calculations. As such, SANDAG was supportive of the bill.

Unfortunately, despite experiencing unanimous support throughout the legislative process, the bill was held by the Senate Appropriations Committee on August 15th, as HCD estimated ongoing costs of approximately \$205,000 annually for staff to convene and moderate stakeholder meetings to consider improvements to the RHNA process, and to publish specified information on the department's website.

Transportation Update from Peyser Associates

Taking Stock During Congressional Recess

The congressional August recess is a time to take stock of where things stand in the annual appropriations process and look ahead to the last four months of the congressional session for the year. As we do those things, here are the key takeaways:

- The timing for the completion of the full-year appropriations bills for fiscal 2025

 if they are completed at all is very uncertain. For fiscal 2024, the process extended into March of this year. Many observers on Capitol Hill believe this year's process will also spill over into the next calendar year. The only thing that might change this calculus is if the election produces a status quo outcome Democrats controlling the Senate and the White House and Republicans controlling the House.
- If a full-year spending bill for Transportation-HUD is completed, this year's dynamic looks similar to last years: the final product is likely to look a lot more like the Senate's spending levels than the House's.
- Depending on the amount of turmoil Members are experiencing after the election, a full-year Continuing Resolution could become a viable option. If that comes into play, earmarks would be in serious jeopardy.
- The pre-election part of the fall session is likely to be almost completely consumed by discussions over the length and contents of a Continuing Resolution to keep the government running after September 30. A CR until November 15 or so is a good bet.

House and Senate Appropriations Bills Poised for Floor Action, But May Not See It

As noted above, there is a lot of uncertainty surrounding the process for approving annual spending bill, including the Transportation-HUD measure. It is entirely possible that this year we will see the House and Senate produce a final agreement without either body having passed its own version of the bill first. While this is unusual, it can be done procedurally once an agreement is reached by the Senate taking up an unrelated House-passed bill, striking all of its provisions and then inserting the agreed-upon language.
