

California- Baja California Border Resiliency Plan

Overview

On November 22, 2024, the Board of Directors accepted a \$3 million planning grant from Caltrans Sustainable Transportation Planning Grant (STPG) Program to develop the California- Baja California Border Resiliency Plan (BRP). The BRP is a comprehensive, binational plan that prioritizes climate adaptation and resilience of transportation infrastructure within the border region, focusing on the communities ten miles to the north and south of the border from the Pacific Ocean, east to the California-Arizona border. The BRP will develop strategies and recommendations to address climate stressors and resiliency challenges while maintaining and strengthening binational coordination - building on

many years of work being led by border region community leaders, agencies and stakeholders.

Key Considerations

A Notice to Proceed (NTP) was issued by Caltrans on January 22, 2025, to begin work on the BRP. The BRP will develop a vetted and prioritized list of strategies, programs, and projects to address climate adaptation challenges affecting environmental justice communities in the border region and the transportation network serving them. This effort is similar to work led by Caltrans and the State of Baja California (via the Secretariat of Infrastructure, Urban Development, and Territorial Reorganization) for the California - Baja California Border Master Plan (BMP) for transportation infrastructure.

The BRP will identify the various climate and public health challenges affecting the border region, evaluate existing and planned efforts by federal, state and/or local agencies to address these challenges, and identify any potential gaps. It will include extensive outreach and collaboration with border region communities, public agencies, academic research institutions, and other stakeholder groups to develop strategies that address the climate challenges and improve resiliency and equity. It will include a list of priority projects, identify potential lead entities, propose financial strategies for implementation, and recommend metrics for tracking progress on the various efforts. In addition, the final BRP will also propose a roadmap for future integration of its climate and environmental justice elements into the existing BMP process.

Since issuance of the NTP, SANDAG has been working in partnership with Caltrans, the Southern California Association of Governments, and the State of Baja California as members of the Project Development Team (PDT) to carry out project activities supporting development of the BRP. A new BRP Interagency Task Force was formed to provide technical guidance and recommendations on the BRP for the duration of this grant. Membership of the Taskforce consists of binational representatives from federal, state, local and tribal governments and agencies; all representing disciplines and interests involved in environmental planning, climate adaptation and environmental justice issues. The first Task Force meeting was held on April 30, 2025, with over 50 attendees, representing 14 agencies from the U.S, 9 from Mexico and 2 with binational interests.

SANDAG continues to work with the PDT and Task Force to gather all existing information on efforts underway, including identification of groups and organizations that are currently addressing resiliency needs in the California-Baja California border region. A draft Communication and Stakeholder Outreach Plan has been developed that details how we plan to engage our stakeholders and communities to gather feedback on what adverse climate impacts exist, how we can improve our transportation system to better adapt to those conditions, and what issues should be prioritized to address the immediate needs of residents today while building a more resilient transportation system for the future.

Next Steps

Near-term actions include procurement of consultant services to assist in the development of the BRP and stakeholder and community outreach, continuation of the identification of existing groups, data and data gaps, and finalization of the Public Participation and Stakeholder Outreach Plan. Initial outreach is set to begin mid-summer, and staff will host the 2nd California- Baja California Border Resiliency Plan Interagency Task Force in late July. Staff will bring regular updates on the progress of the grant to the Borders Committee.

California-Baja California Border Resiliency Plan Interagency Task Force

Task Force Charter

Purpose

The purpose of the California-Baja California Border Resiliency Plan Interagency Task Force (Task Force) is to provide technical guidance, background knowledge and interagency coordination to address climate adaptation challenges affecting environmental justice communities in the border region and the transportation network serving them. These efforts will support the development of the California-Baja California Border Resiliency Plan (Cali-Baja BRP) under the Caltrans Sustainable Transportation Planning Grant.

Responsibilities

This group will serve as a body of technical subject-matter experts in environmental and climate adaptation issues affecting the border region. The Task Force provides an institutional forum and structure for regional stakeholders to: (1) collaborate, coordinate and peer exchange solutions to address issues related to climate stressors and resilience within the California-Baja California border region; and (2) provide a regional collaboration among the jurisdictions and stakeholders on the development of the Cali-Baja BRP.

Membership

By "Task Force" we mean a broad range of staff representatives of those jurisdictions along the border region, including all cities within or adjacent to the project area. Additionally, the Task Force will include staff representatives of federal, state, and local agencies, and tribal governments that are directly involved in the implementation of environmental efforts along the California- Baja California border. Table 1 includes a preliminary list of Task Force members. Additional members will be added based on subject matter expertise as needed.

Task Force member agencies are asked to designate an alternate representative when the primary representative is unable to attend to promote participation in meetings.

Commitment / Duration of Existence

Task Force participants are asked to attend and participate in Task Force meetings to share information and give feedback on environmental issues facing the border region, including input on issues related to coordination and implementation of the Cali-Baja BRP grant. The Task Force will meet on a quarterly or as-needed basis, for a total of eight (8) meetings.

The Task Force will meet for the duration of the Cali-Baja BRP development timeline through April of 2027.







Regional Safety Planning Updates

Overview

SANDAG, the La Jolla Band of Luiseño Indians, and the City of Vista successfully applied for a joint safety planning grant in 2023. The agencies coordinated their efforts including sharing safety data and analysis, and public engagement. The regional, tribal, and local plans identify where the greatest concentration of serious and fatal injury crashes occur, identify potential countermeasures, and establish tribal and local agency eligibility for federal safety funding.

SANDAG and La Jolla Band of Luiseño Indians staff will present an overview of regional and tribal safety planning efforts.

Key Considerations

Final Regional Vision Zero Action Plan

On June 22, 2022, the SANDAG Board of Directors adopted Resolution No. 2023-02 directing staff to seek funding and develop a regional Vision Zero Action Plan (VZAP) to advance traffic safety goals for the San Diego region. Developed in collaboration with local agency staff, the VZAP Technical Advisory Group 1, Interagency Technical Working Group on Tribal Transportation Issues, community-based organizations and the public, the VZAP identifies local traffic safety challenges and solutions to support Vision Zero. The plan identifies where the most fatal and serious injury crashes occur and provides resources to improve safety in those areas. The plan also details SANDAG's role in implementing safety solutions and how progress toward Vision Zero will be evaluated. With the VZAP finalized, local agencies and tribes are eligible for Safe Streets and Roads for All implementation grants. The final VZAP and its technical appendices are available on SANDAG's Vision Zero webpage.

Comprehensive Safety Action Plans

The La Jolla Band of Luiseño Indians and the City of Vista have developed respective Comprehensive Safety Action Plans (CSAP) for their transportation systems. These plans provide more granular analysis of safety data and safety countermeasure project recommendations. The La Jolla Band of Luiseño Indians adopted their CSAP on April 30, 2025, which can serve as a template for other tribes interested in developing their own CSAP. The La Jolla Band of Luiseño Indians is advancing implementation steps for safety countermeasures on State Route 76. The City of Vista adopted their CSAP on May 13, 2025, and is now progressing with implementation of projects specified in the plan.

Action: Information

SANDAG and La Jolla Band of Luiseño Indians staff will present the final regional Vision Zero Action Plan, tribe Comprehensive Safety Action Plan, supporting safety tools, and regional safety statistics.

Fiscal Impact:

Completion of the Vision Zero Action Plan (VZAP) establishes tribal and local agency eligibility for federal Safe Streets and Roads for All implementation grants.

Schedule/Scope Impact:

The regional VZAP was completed on November 15, 2024.

¹ The Technical Advisory Group (TAG) consisted of multidisciplinary community members with diverse perspectives including local jurisdictions, transit agencies, tribal nations, community-based organizations, Vision Zero advocacy groups, first responders, health professionals, education professionals, and law enforcement.

Regional VZAP Implementation Steps

The regional VZAP includes implementation steps that are organized under seven focus areas: Coordinate, Advocate, Plan, Fund, Educate, Evaluate, and Implement. Multiple implementation efforts are currently in progress and SANDAG has recently launched three including: California Assembly Bill 43 (Schultz) technical support², local agency countermeasure tool development³, and grant criteria updates⁴.

Next Steps

SANDAG will advance implementation steps identified in the VZAP in coordination with partner agencies and tribal governments. Staff are working with local agencies and tribes on project ideas for the current Safe Streets and Roads for All grant opportunity.

² AB 43 establishes more flexible speed limit setting for municipalities. SANDAG developed a Safety Corridor Network for each jurisdiction to identify portions of each jurisdiction's roadway network that can be eligible for a 5-mph speed limit reduction.

³ An online platform for local agencies has been developed to share safety data, resources, support safety project development, and countermeasure selection.

⁴ Regional Active Transportation Program and Smart Growth Incentive Program evaluation criteria have been updated to further safety goals and leverage the regional VZAP analyses.







Rural Safety Data – Key Takeaways

- Solo crashes and head on crashes were the most prevalent crash types in rural areas.
- There were five-times more crashes per-mile on 4-lane roads than 2-lane roads in rural areas.
- With a lower population density, rural areas had a higher crash rate and mileage on the Safety Focus Network per-capita than urban areas.
- Midblock crashes are more likely to result in a fatality or serious injury than a crash at an intersection.

Urban Safety Data – Key Takeaways

- Crashes involving a pedestrian crossing the street are more common in urban areas.
- The rate of fatal and serious injury pedestrian crashes on four lane roads double near multi-family residential land use.
- Over 80% of fatal and serious injury crashes in which the pedestrian was crossing and the motorist was going straight happened near commercial or multifamily residential land uses.
- Crashes along 35 mph roads near commercial land uses have roughly 6 times the rate of all crashes and 7.5 times the rate of fatal and serious injury crashes per road mile compared to roadways not near commercial land uses.

Collisions by Injury Severity 20 20 15 Complaint of Other Visible Severe Fatal Pain Severity




