# 2025 Regional Plan: Draft Series 15 Regional Growth Forecast Subregional Results

#### Overview

The 2025 Regional Plan is being developed based on a data-driven process that starts with updating the regional growth forecast. Draft Series 15 Regional Growth Forecast results for the San Diego Region were presented to the SANDAG Board of Directors in July 2023. Today, Draft Series 15 Regional Growth Forecast results are presented at both the regional and subregional level to members of the Sustainable Communities Working Group (SCWG).

### **Key Considerations**

To develop a long-range plan, we first need to understand what the region will look like in the future. To do so, SANDAG prepares a Regional Growth Forecast that considers historical data in combination with expert opinion and jurisdiction input to forecast how the population of the San Diego Region will change, how many households and housing units there will be, and how many jobs will exist in the region.

### Action: Discussion

Staff will present the Draft Series 15 Regional Growth Forecast results at the both the regional and subregional level.

#### **Fiscal Impact:**

Development of the 2025 Regional Plan is funded under Overall Work Program Project Nos. 3103000 and 3100405.

#### Schedule/Scope Impact:

The Draft Series 15 Regional Growth Forecast, including both regional and subregional results, is expected to be brought to the Board of Directors in March 2024. The 2025 Regional Plan is expected to be brought to the Board of Directors for approval in late 2025.

The Draft Series 15 Regional Growth Forecast results for the San Diego Region were presented to the SANDAG Board of Directors in July 2023. Key points of the region forecast results that directly influence subregional results presented here are the following:

- Population in the region will grow from base year 2022 through 2040 and then begin to decrease approaching horizon year 2050.
- The population will get older, as the median age is projected to increase from 36 in 2022 to 42 in 2050.
- Demand for housing will continue to be strong as the forecast expects housing units to continually be added through 2050.

SANDAG staff have worked collaboratively with the nineteen member jurisdictions to prepare a subregional forecast. The subregional forecast allocates population, housing, and jobs to the region's jurisdictions, based on the numbers projected at the region level using jurisdiction inputs. Today, SANDAG presents Draft Series 15 Regional Growth Forecast results at both the regional and subregional level to Sustainable Communities Working Group (SCWG) members.

### **Next Steps**

The Draft Series 15 Regional Growth Forecast is expected to be brought to the Board of Directors in March 2024 for discussion. The 2025 Regional Plan is expected to be brought to the Board of Directors for approval in late 2025.

# **Terminology**

#### Series 15 Regional Growth Forecast (RGF)

- Demographic and economic forecast used to inform the 2025 Regional Plan
- Series 15 is the latest series, replaces Series 14 used in the 2021 Regional Plan. Regional Growth Forecasts are refreshed on fouryear cycles incorporating latest inputs from jurisdictions, recent trends, and datasets.
- Pursuant to California Government Code 65584.01(a), Regional population growth is within +/-1.5% of most recent California Department of Finance population projection (Vintage 2023; 2023.7.19)
- Base year = 2022; Horizon year = 2050\*

#### Sustainable Communities Strategy (SCS)


- Requires planning scenario that shows alignment of transportation, housing, and land use that supports meeting SANDAG's greenhouse gas emission reduction targets set by California Air Resources Board (CARB) per SB375
- Separate process informed by Series 15 jobs, population, and housing
- Typically, SCS envisions majority of growth in existing urban and infill areas, co-located near transit investments, with the goal of reducing vehicle miles traveled
- SCS land use scenario "shall consider existing residential zoning obligations to accommodate RHNA of the current housing element planning period.."

### Regional Housing Needs Assessment (RHNA)

- Plan for addressing 8-year cycle of housing growth. Housing and Community Development (HCD) considers Department of Finance data on future population and housing growth to determine regional housing need
- 6th Cycle Determination & Allocation: 2021-2029, 171,685 units
- 7th Cycle Determination & Allocation: Not started




## **Statutory Requirement for SANDAG Regarding** California Department of Finance Projections



- Pursuant to California Government Code 65584.01(a), SANDAG's Regional Growth Forecast for population growth is required to be within +/-1.5% of most recent California Department of Finance population projection at the time the Forecast is prepared
- Series 14 Forecast was paired to an earlier DOF projection (2020.1.10) which was substantially higher than the current DOF projection (2023.7.29) that Series 15 is paired with
- The 6th Cycle RHNA was paired to an earlier DOF projection (2019.3.27), which was even higher





- In 2029, net migration (55,495) is projected to exceed natural change (52,184) and become the driver of population for the State into 2050
- Natural change (births deaths) is projected to become negative by 2035 and continue decreasing out to 2050











## San Diego Region: Components of Population Change








## San Diego Region: Housing Units by Structure Type







### **Active Transportation Program Cycle 7 Call for Projects**

#### Overview

The Active Transportation Program (ATP) is administered by the California Transportation Commission (CTC) and distributes funding for active transportation projects. Approximately \$568 million in state and federal funds is anticipated to be competitively awarded by the CTC in the upcoming cycle. Funding is competitively awarded in two stages, beginning with a statewide competition led by the CTC, followed by a regional competition conducted by the Metropolitan Planning Organization (MPO) of each region.

### **Key Considerations**

The CTC provided the draft ATP Guidelines and Fund Estimate on January 25, 2024, and is scheduled to consider approval of the final Guidelines and Fund

Action: **Discussion**Staff will present an overview of the Cycle 7
Call for Projects.

### Fiscal Impact:

Pending adoption by the Board of Directors and the California Transportation
Commission, Cycle 7 of the Regional ATP would provide approximately \$20.6 million in state and federal funding to active transportation projects.

### Schedule/Scope Impact:

Funding would be available for projects between 2026 and 2029.

Estimate at its meeting in March 2024. Changes made to the Guidelines from the prior cycle include a requirement that at least 40% of the federal funding must benefit communities identified as disadvantaged by the Biden Administration's Justice40 Initiative, and a new application submission portal. The Program is expected to provide approximately \$568 million between Fiscal Year (FY) 2026 and FY2029 for active transportation projects, including approximately \$20.6 million for the San Diego Regional program.

Staff is bringing draft evaluation criteria for discussion with SANDAG Working Groups and Policy Advisory Committees for input. Feedback received will be used in the development of the final call for projects.

### **Next Steps**

Staff will update the evaluation criteria and bring the final call for projects for consideration to the Transportation Committee and Board of Directors in April 2024. Pending action by the Board of Directors, staff will submit the draft Call for Projects to the CTC, and the CTC is scheduled to consider the adoption of the Call for Projects at its June 2024 meeting. If approved, SANDAG will release the Cycle 7 regional Call for Projects, and applications will be due in September 2024. The funding recommendations would be brought to the Transportation Committee and Board of Directors in March 2025.

### **Regional Safety Planning Updates**

#### Overview

On June 22, 2022, the SANDAG Board of Directors adopted Resolution 2023-02 directing staff to seek funding and develop a Vision Zero Action Plan (VZAP) to advance regional traffic safety goals for the San Diego Region. This planning effort is included in the 2021 Regional Plan as near-term implementation action and safety is a new goal area for the 2025 Regional Plan.

#### **Key Considerations**

SANDAG Planning Staff worked closely with the Outreach and Engagement team to develop a comprehensive outreach plan to inform the public of the

#### Action: Information

Staff will present an update on regional safety efforts in developing the Regional Vision Zero Action Plan.

### **Fiscal Impact:**

Completion of the Vision Zero Action Plan will make local agencies eligible for federal safety grant funds.

### Schedule/Scope Impact:

The regional Vision Zero Action Plan is scheduled to be completed in summer 2024.

VZAP's goals, process, and opportunity to participate. Staff developed a robust e-toolkit including sample social media and eblast copy, photos, graphics, and other resources for stakeholder groups to share with their communities. SANDAG staff also provided a "roadshow" of presentations to various committees including Transportation Committee, Military Working Group, and the Social Equity Working Group about the importance of traffic safety and the undertaking of a VZAP.

Additionally, SANDAG created an interactive portal (Sandag.org/SaferStreets) to allow people within the San Diego region to identify exact intersections where they would like to see safety improvements and provide feedback about their safety concerns. Nearly 3,000 comments were received through the interactive outreach mapping tool. The project team has worked with participating community-based organizations to develop an interactive pop-up kit that will be supporting outreach in the spring of 2024. A multidisciplinary Technical Advisory Group (TAG) and subregional local agency project development teams also have convened to provide input on VZAP plan development and will continue to meet through the completion of the plan.

#### Data Analysis Updates

SANDAG has launched the Traffic Safety Dashboard that includes more than a decade of robust, thoroughly analyzed crash data in an easy to use and explore platform. Data from this dashboard is the foundation of the VZAP data analysis, and will inform future decision makers about the traffic and safety conditions in their jurisdictions. Key VZAP deliverable updates include: agency benchmarking,<sup>1</sup> existing conditions analysis<sup>2</sup>, draft safety focus network, and prioritization processes.

The draft safety focus network identifies the segments of the roadway network with the highest concentrations of fatal and series crashes. The draft composite safety focus network identified that 54% of fatal and serious injuries occurred on 6% of the network. Additionally, two prioritization processes are being developed to further refine location and safety improvement options on the safety focus network and to look proactively at locations that have higher risk for future crashes.

#### **Next Steps**

VZAP development is scheduled to conclude in early summer 2024. This planning initiative will continue engaging the public, including community-based organizations, through the spring to inform plan development. Development of a safety improvements toolkit will provide agencies with information for selecting and

The existing conditions analysis examines reported crash data from 2018-2022 to understand crash patterns related to sociodemographic, behavior, and related roadway and contextual data.

implementing projects. Periodic updates on plan progress will be provided to SANDAG working groups, and policy advisory committees. The development of this plan will serve as a vital input for the 2025 Regional Plan and future planning efforts and allow local agencies to be eligible for federal safety grant funds.




