Available Funding and Award Sizes

- Available Funding: **\$4.5 million**
 - Federal Highway Administration (FHWA) Regional Surface Transportation Program (RSTP)
- Maximum Award:
 - New Pilot: \$1,000,000
 - Enhanced Pilot: \$500,000
- Matching funds
 - 11.47% of Total Project Cost

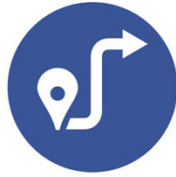

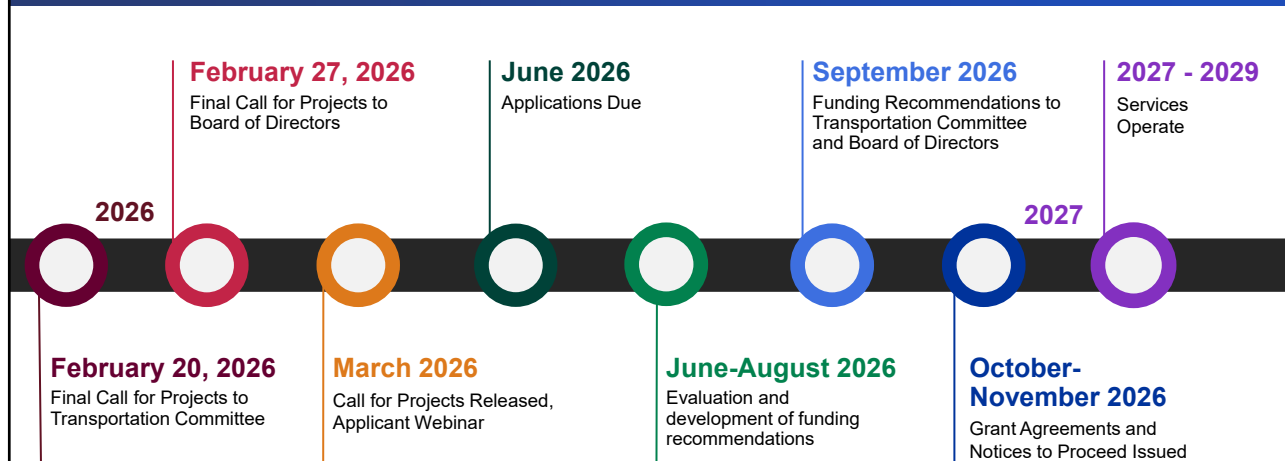
