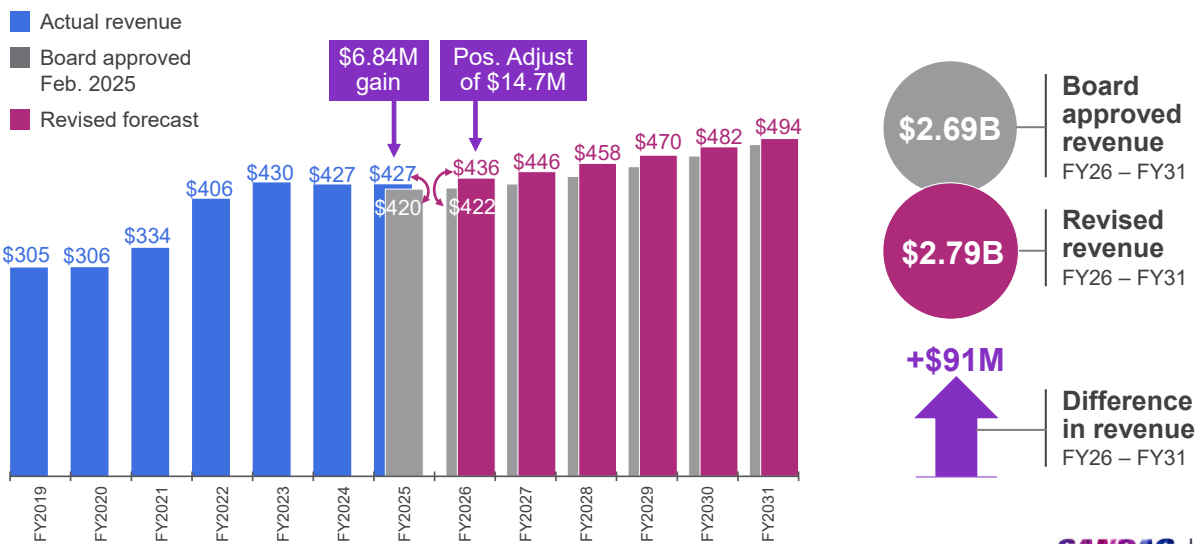

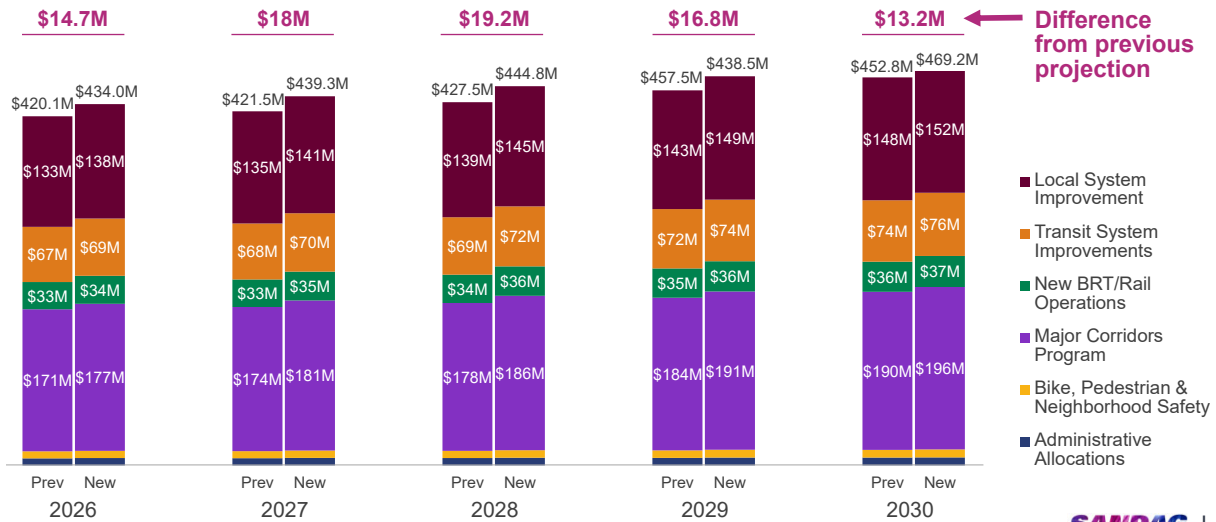
## TransNet Revenue
