FY 2024 TransNet Local Streets and Roads Program Annual Status Report

Overview

The [FY 2012 TransNet Triennial Performance Audit](#) report included Recommendation Nos. 3 through 6, which proposed that SANDAG take a greater role in monitoring and reporting the performance of the Local Streets and Roads program. In 2013, through collaboration with both the TransNet Independent Taxpayer Oversight Committee (ITOC) and members from local City and County agency representatives through the Cities/County Transportation Advisory Committee (CTAC), SANDAG staff developed an annual reporting process and template to highlight TransNet projects and programs by jurisdiction to address the performance audit recommendations.

Key Considerations

Attachment 1 includes the annual status report on each jurisdiction's TransNet Local Streets and Roads program projects for the period covering July 2023 to June 2024. Each jurisdiction is responsible for deciding which street and road projects to undertake, as long as the projects remain within the 70 percent Congestion Relief and 30 percent Maintenance guidelines. Significant progress highlights include:

- The City of Carlsbad replaced approximately 1,700 streetlight bulbs with LEDs; and completed ADA improvements for 10 parking lots.
- The City of Chula Vista constructed 1,716 linear feet of sidewalk; installed driveways and 15 ADA pedestrian ramps.
- The City of Lemon Grove cleared 37,840 square feet of drainage channels of debris and vegetation; and performed maintenance on 30 traffic signals.
- The City of Oceanside added asphalt overlay on 27 miles of roadway; and performed slurry seal on 13 miles of roadway.
- The City of San Diego added 3-inch asphalt overlay on 142,013 square feet of roadway; and installed 109 Traffic Detector Loops.
- The City of Vista added asphalt overlay on 32 lane miles of roadway; and performed slurry seal on 70 lane miles of roadway.

Next Steps

The next annual Local Streets and Roads program report is planned to be presented at the end of FY 2025. Staff will continue working with ITOC and the Mobility Working Group to complete annual reporting on Local Streets and Roads Program projects.
